available for doctors will also be shared. Registration is limited to 40 participants.

Medical Officer, Health (R/South Ward) has been requested to talk on Filling of the Medical Certification of Cause of Death (MCCD). She will share her availability on the same.

Dr. Saurabh Dani added that the program is being sponsored by HDFC, which will bear all costs.. Registration is free but compulsory.

f) Public Awareness

Dr. Mona Badani shared that a workshop and training program was conducted on 6th July, limited to 24 delegates to ensure personalized, hands-on learning. The feedback was excellent, with participants appreciating the depth of training and realizing how much more there was to learn.. It was subsidized for KMA members, and more such workshops are planned.

Looking ahead, Dr. Mona Badani proposed organizing an one-hour CPR and AED Sensitization Program in housing societies on 15th August 2025. This session will be free of cost and will not involve hands-on training—just a mic and an audience are needed. It aims to introduce life-saving concepts to the public. She urged members to approach their societies, especially those hosting Independence Day functions, to include this session.

Dr. Saurabh Dani inquired about the eligibility of trainers, asking whether only those with formal certification (e.g., IRCF) can conduct such sessions. Dr. Amola Parikh confirmed that while many doctors may know CPR, official certification ensures proper technique and credibility. **Dr. Dani emphasized that only those with valid IRCF trainer certificates should be allowed to speak on behalf of KMA for this initiative, regardless of their medical qualifications.**

Dr. Utpal Sheth suggested starting with 5–10 societies and expanding gradually. Dr. Mona mentioned that Dr. Kalpesh had already mobilized his entire society and estimated they could reach up to 1500 people. She requested that MC members help identify 15 societies willing to host this program. Since most societies already have Independence
